(the "Association"), do hereby certify that the following amendments to the Bylaws were approved by a vote of a majority of a quorum of members present in person or by proxy at the December 13, 2022 Special Meeting of the Members, after first providing written notice of said meeting via mail, delivery or electronic transmission to the Members of the Association not less than 14 days before the meeting:

I. Article V, Section 1 of the Bylaws of Fawn Ridge Maintenance Association, Inc. is amended to read as follows:

Section 1. Number. Beginning at the Annual Meeting of the Members scheduled for February 15, 2023 and at all times thereafter. The affairs of the Association shall be managed by a Board of three (3) five (5) directors, who need not be members of the Association.

The candidate receiving the most votes shall be elected for a term of three (3) years. The candidate receiving the second most votes shall be elected for a term of two (2) years. The candidate receiving the third most votes shall be elected for a term of one (1) year. At the first annual meeting the members shall elect one (1) director for a term of one (1) year, one (1) director for a term of two (2) years, and one (1) director for a term of three (3) years; and a At each annual meeting thereafter the members shall elect the a director for a term of three (3) years to fill each expiring term.


