- Solar panels are just like any exterior modification to your home, i.e, exterior paint, adding a swimming pool, changing the roof
- There is a community standard and contractors are required to follow guidelines for installation

## Renewing Driveways The Right Way

This is another worthy attempt to advise our residents that a community with deed restrictions

is a community where property values are preserved.

## What do the deed restrictions say about modifying driveways?

Not much, specifically, but modifying a driveway, albeit with interlocking pavers or stamped concrete is a typical exterior modification that requires - you guessed it!

#### **Architectural Modification Application**

- The Board of Directors at its last meeting reaffirmed the prior community standards/ design guidelines for driveway modifications
- Go to fawnridge.org for more information
- Please remember to submit the Architectural Modification Form whenever you are choosing to make an exterior modification and before commencement of work
- A service charge is levied against anyone who makes changes to the exterior without first applying for approval
- Not seeking approval before commencement of work can be an expensive venture
- If the modification is not up to community standards the lot owner may be subjected to removing the improvements

#### Please Read Color Palette Guidelines Before Submitting Colors to ARC.

It will save you a lot of time, money and frustration.

- 1. All exterior paint and repainting <u>must</u> <u>be submitted to Fawn Ridge</u> Architectural Committee (ARC)
- 2. Approved Exterior Paint colors found on 1<sup>st</sup> page of <u>FAWNRIDGE.ORG</u>
- 3. Only approved paint colors which are listed are permitted.
- 4. Must use a <u>minimum of two (2) and a</u> <u>maximum of three (3) colors</u> are permitted per home.
- 5. One color must be declared as the house body color.
- 6. Any siding must be painted house body color only.
- 7. If home <u>needs repainting than an</u> <u>approved color</u> from palette must be selected.
- Colors <u>shall not be similar to adjacent</u> <u>homes</u>. Trim color must be <u>within</u> <u>three (3) shade colors up or down, on</u> the same color strip as the body.- or one of the trim ONLY colors.
- 9. There are five (5) approved white house colors on the palette. The trim must be within the top three (3) colors on any trim/body color strip on the palette.
- 10. Garage door must match body or trim of units' exterior color or simulation wood finish.
- 11. Sheen of the paint finish may not exceed semi-gloss for the house body.


